**Formation of Institute Level Anti Ragging Committee: 2024-25**

In Pursuance to the directions of the Hon'ble Apex Court in SLP No 24295 of 2006, dated 16.05.2007 and in Civil Appeal No 887 of 2009, dated 08.05.2009 and Vide AICTE Notification F.No. 337-3 / Legal / AICTE / 2009 dated 01.07.2009, an institute Level **Anti Ragging Committee** has been constituted with immediate effect to prevent and prohibit ragging in the institution premises.

It shall be the duty of the Anti-Ragging Committee to ensure compliance with the provisions of these UGC and AICTE Regulations as well as the provisions of any law for the time being in force concerning ragging; and also to monitor and oversee the performance of the Anti-Ragging Squad in prevention of ragging in the institution.
